



## MainGate Year-End Tax Reporting Update

**MEMPHIS, November 12, 2012** — The MainGate MLP Fund (the “Fund”) — AMLPX; IMLPX — is taxed as a C-corporation. Therefore, while shareholders receive annual 1099 DIV Statements related to income distributions received on their investment, the character of income derived generally varies from the character of income derived from mutual fund investments. For example, Fund shareholders do not receive flow-through capital gain treatment on any income distributions received.

The Fund will provide shareholders with a 1099-DIV STMT in early 2013 to reflect the dividends received from the Fund during 2012.

The Fund distributed \$0.63 per share in distributions during 2012, detailed as follows:

It is anticipated, but not certain, that a majority of the distributions from the Fund will be treated as a return of capital. Fund distributions designated as a return of capital on shareholder 1099 DIV Statements are not taxable and are a reduction to an investor’s tax cost basis. The final determination of the tax character of Fund distributions will be made in early 2013, after the end of the calendar year, when the Fund determines its earnings and profits for the year. The final tax status of the distribution may differ substantially from this preliminary information.
